A roll call of the Board of Directors of the CCIDA was taken Mr. Buffamante, Mr. Higgins, Mr. Snyder, Mr. Driscoll, Ms. Schroder, and Mr. Wimer were present. Mr. Stahley was excused.

New Applications/Projects

MJ Painting Contractor Corp.

Mr. Wiktor introduced Mr. Mike John to have him give an overview of this potential project. Mr. John stated that he purchased the 9.5-acre property at 350 Franklin Street in the City of Olean in 2018. His future plans are to use part of the property to construct a new paint shop and there will still be 4/5 acres for additional development. He is seeking sales tax abatement, and possible mortgage recording tax abatement. Mr. John stated that he had purchased additional land in 2014 and invested in three (3) new buildings. Their business currently is operating in 18 different states and they are very dedicated to their vendors in the Olean area, as most of their work is being completed out of the Olean area. Ninety five percent of their goods are purchased locally from the Olean area vendors.

Mr. John thanked the CCIDA for considering his current project and for assisting him with all of his past projects.

MJ Painting has submitted an application to the IDA for a project located at 350 Franklin Street, Olean, NY.

MJ Painting has entered into an agreement with NYSDEC as part of the Brownfield Cleanup Program to remediate the site located at 350 Franklin Street in the City of Olean, for the purpose of future expansion of MJ painting's business with an approximate 15,000 sq. ft. office and paint shop building.

A Roll Call vote was taken, Mr. Buffamante, Mr. Driscoll, Ms. Schroder, Mr. Wimer, Mr. Snyder, and Mr. Higgins voted yes. Mr. Stahley was excused. Motion Carried (Mr. Buffamante stated that his firm does do work for MJ Painting Contractor Corp., however they have no financial interest in the Company or this particular project.)

River Valley Solar LLC:

River Valley Solar has asked the CCIDA to approve the request for consent to assignment by which River Valley Solar will be selling its project assets to Nautilus Owner 2021, LLC at the end of June 2021lus team will still be responsible for managing and owning the solar project going forward, but pursuant to the underlying document s and any transfer of the PILOT documents it is required to have the IDA's consent.
