Chairman, Thomas Buffamante called the meeting to order at 11:17 a.m.

Mr. Wiktor stated that because of the COVID19 Pandemic we are holding the CCIDA Board Meeting via conference call.

A roll call of the Board of Directors of the CCIDA was taken Mr. Buffamante, Mr. Driscoll, Mr. Higgins, Mr. Snyder, and Mr. Wimer, and Mr. Stahley and Ms. Schroder were present. The full CCIDA Board were present.

APPROVAL OF MINUTES:

A Motion was made by Brent Driscoll with a second by Michael Wimer to accept the February 6, 2020 CCIDA Board Meeting Minutes as presented. Motion Carried

* Presentation of 2019 Annual Audit CCIDA/CCCRC:

Mr. Wiktor stated that an Audit Committee meeting was held on March 19, 2020 to discuss the Draft 2019 Audit. Copies of the minutes of the meeting were provided to the CCIDA Board.

Mr. Buffamante next introduced Ms. Denise Veloski from Johnson, Mackowiak & Associates to discuss the 2019 Draft Audit with the CCIDA Board.

Denise stated that this was a clean Audit noting there was no need for the Auditors to include a Management Letter, noting procedures and processes were followed and adhered to in 2019. Denise also mentioned that a few minor adjustments were made in the wording in the Audit as suggested by the Audit Committee.

Denise then discussed the Management Discussion and Analysis information that was provided the Auditors by Corey Wiktor in regards to current, ongoing and projects in the works. It was also discussed that the net position has decreased by \$143,000 which was mainly due to a timing issue with the closing of several projects in the works that have been pushed into early 2020. Mr. Wiktor stated that currently through February 2020 we have income totaling \$320,000. Mr. Wiktor advised the CCIDA Board that a few projects that were slated to close in 2019 slid into the first week of 2020 of which we had no control over.

Denise mentioned that the expenses for 2019 were consistent with the expenses for 2018. Denise also mentioned that there was a transfer made from the CCCRC to the CCIDA checking account. This transfer was approved by Mr. Buffamante and done to cover expenses while waiting for several projects to close. This money has already been returned to the CCCRC account just after the first of the year however, it was stated in the Audit because CCIDA and CCCRC are reported separately. Denise also discussed the Net Pension Liability of \$48,470 this information is provided by New York State.

Denise stated that the Administrative Services charges for 2019 were \$5,000 because there was no bond issued by the CCCRC in 2019. Also, the \$40,000 transfer out shows on the Statement of Activities of the Audit and as discussed previously this amount has been returned to the CCCRC. The Net Cash has decreased at year end by \$126,000. Denise also stated that the CCIDA/CCCRC was completely covered by collateral or FDIC on all accounts. Denise noted that the coverage on all accounts has been going very well for the last few years.

The amount paid to New York State Pension was up slightly from 2018 up to \$22,438 this number is based on payroll.

Denise stated that there were a lot of new Accounting Standards that were issued however, no of them affected the financial statements of the CCIDA or the CCCRC.

Denise briefly discussed the Schedule of Bonds which include the balance at the beginning of the year and the amount paid during the year with the balance shown at year end. No new bonds were issued in 2019 also this schedule shows both the CCIDA and the CCCRC. The next thing the financials show are the Schedule of Leases entered into in 2019 and also any new PILOTS that were issued in 2019 to Projects being assisted by the CCIDA.

The Audit ended with a letter from Johnson, Mackowiak & Associates LLP in regards to Internal Controls and Compliance which had no matters to report.

Mr. Wiktor stated that the CCIDA Staff tries very hard to limit the monthly discretionary expenses. We also keep an eye on the Certificate of Deposit investments to try and earn as much interest as possible on all investments.

The Audit Committee made a motion to accept the minutes of the Audit Committee meeting and make a recommendation to accept the 2019 Audit as presented.

A Motion was made by Brent Driscoll, seconded by Michael Wimer to accept the 2019 Annual Audit by Johnson, Mackowiak & Associates LLP with a few minor changes. A Roll Call vote was taken, Mr. Buffamante, Mr. Driscoll, Mr. Higgins, Mr. Snyder, Mr. Wimer, Mr. Stahley, and Ms. Schroder voted yes. **Motion Carried**

New Applications/Projects

(#1.) 3M Property Management, LLC:

3M Property Management, LLC has asked the County of Cattaraugus Industrial Development Agency (CCIDA) to consider their application for the complete renovation and rehab of the former "Olean Standards" building, located on W. State Street in the City of Olean. The project related to the building has been largely vacant and or underutilized for the past 3 years.

To date, plans are in development stage to bring a mixture of retail to the ground floor, and to construct four (4) high end apartment rental units on the upstairs of the location.

The Total project cost/investment is \$250,000.

Ginger Schroder asked if Fidurko Brothers Construction was the General Contractor on this project or if this project has not been started? Corey Wiktor advised Ms. Schroder that he will look into this matter and get back to her with an answer.

A Roll Call vote was taken, Mr. Buffamante, Mr. Driscoll, Mr. Higgins, Mr. Snyder, Mr. Wimer, Mr. Stahley, and Ms. Schroder voted yes. Motion Carried

A Motion was made by Joseph Higgins, seconded by Michael Wimer, RESOLUTION AUTHORIZING EXECUTION OF DOCUMENTS IN CONNECTION WITH A LEASE/LEASEBACK TRANSACTION FOR A PROJECT FOR 3M PROPERTY MANAGEMENT LLC (THE "COMPANY"). A Roll Call vote was taken, Mr. Buffamante, Mr. Driscoll, Mr. Higgins, Mr. Snyder, Mr. Wimer, Mr. Stahley, and Ms. Schroder voted yes. Motion Carried

-(#2.) River Valley Solar, LLC:

River Valley Solar, LLC has asked the County of Cattaraugus Industrial Development Agency (CCIDA) to consider their application for the construction and installation of a 5 MW Solar Farm that will be constructed on 21 acres in the Town of Allegany, NY.

This project will participate in the NY-SUN Community Solar Program administered by NYSERDA. The Total project cost/investment is \$11,500,000. Ms. Schroder stated that she had reached out to the Legislators in the area and received an e-mail in support of this project with no negative comments thus far. To date, the Town has been supportive of this proposed project as well.

Mr. Wiktor stated that this project would be subject to the new UTEP policy that is currently in place. Mr. Wiktor stated the Public Hearing will be held via conference call and Zoom video conference to comply with the Governor's order.

A Motion was made by Brent Driscoll, seconded by Joseph Higgins, RESOLUTION DIRECTION THE EXECUTIVE DIRECTOR OF COUNTY OF CATTARAUGUS INDUSTRIAL DEVELOPMENT AGENCY TO TAKE CERTAIN ACTIONS UNDER ARTICLE 8 OF THE ENVIRONMENTAL CONSERVATION LAW IN CONNECTION WITH A PROPOSED PROJECT TO BE UNDERTAKEN FOR THE BENEFIT OF RIVER VALLEY SOLAR LLC. A Roll Call vote was taken, Mr. Buffamante, Mr. Driscoll, Mr. Higgins, Mr. Snyder, Mr. Wimer, Mr. Stahley, and Ms. Schroder voted yes. Motion Carried

-Uniform Tax Exemption Policy - Solar:

Mr. Wiktor advised the CCIDA Board that two (2) Public Hearings were held on March 16th pertaining to the proposed changes to the Agency's UTEP for commercial solar installations. The first hearing was held 10:30 a.m. in the Olean City Hall and at 5:00 p.m. at the CCIDA Office. The minutes from both meetings have been provided to the CCIDA Board for their information. These hearings were to discuss the proposed changes to the Agency's UTEP relating to dollar amounts per installed capacity for, commercial solar installations in Cattaraugus County. The Agency received very few comments on the proposed changes, and most were supportive of the increased dollar amounts.

Mr. Wiktor thanked the CCIDA Board for their guidance and assistance in proposing the changes to the Solar component of our current UTEP. This has been a long process however, Mr. Wiktor feels comfortable with the outcome.

A Motion was made by Joseph Higgins, seconded by Michael Wimer, RESOLUTION ADOPTING COUNTY OF CATTARAUGUS INDUSTRIAL DEVELOMENT AGENCY'S UNIFORM TAX EXEMPTION POLICY. A Roll Call vote was taken, Mr. Buffamante, Mr. Driscoll, Mr. Higgins, Mr. Snyder, Mr. Wimer, Mr. Stahley, and Ms. Schroder voted yes. Motion Carried

-Portville Solar 1, LLC: (Borrego Solar)

Portville Solar, LLC has asked the CCIDA to consider their request for the term of their PILOT from 15 to 25 years along with a proposed dollar amount relating to the PILOT. This project was originally approved in 2019, and since then the developer is asking the Agency to agree to a 25 year PILOT and increased dollar amounts for the PILOT. Emails from the Developer were shared with the Board Members to have them consider.

After much discussion and thought, Mr. Snyder suggested that we give the developer the option to keep the old policy at 15 years or go with the new policy for the 25 years as a counter offer.

A Motion was made by Brent Driscoll, seconded by Joseph Synder to make a counter offer to Borrego Solar of accepting the 15-year Solar PILOT which was in effect when their application was first Induced by the Agency or go with the new recently passed UTEP with a term of 25 years. A Roll Call vote was taken, Mr. Buffamante, Mr. Driscoll, Mr. Higgins, Mr. Snyder, Mr. Wimer, Mr. Stahley, and Ms. Schroder voted yes. Motion Carried

George Cregg, Jr. stated that he would advise Nadene Zeigler to present this counter offer to Portville Solar 1 Legal Team and we would plan to have a new revised Resolution at our April 2020 CCIDA Board Meeting.

RESOLUTION;

A Motion was made by Joseph Higgins, seconded by Michael Wimer, RESOLUTION AUTHORIZING THE EXECUTIVE DIRECTOR TO SEND A LETTER TO THE CHIEF EXECUTIVE OFFICERS OF THE AFFECTED TAXING ENTITIES INFORMING THEM OF A PROPOSED DEVIATION FROM THE AGENCY'S UNIFORM TAX EXEMPTION POLICY

IN CONNECTION WITH THE PROPOSED PORTVILLE SOLAR 1, LLCT PROJECT. A Roll Call vote was taken, Mr. Buffamante, Mr. Driscoll, Mr. Higgins, Mr. Snyder, Mr. Wimer, Mr. Stahley, and Ms. Schroder voted yes. **Motion Carried**

*New York & Lake Erie Railroad Proposed Contract Renewal:

The County of Cattaraugus Industrial Development Agency is looking to renew its Operating Agreement with our standing rail operator, The New York & Lake Erie Rail Road – Mr. Robert Dingman. As with past practice, we are proposing to renew this contract for a term of five (5) years. Please see the proposal provided for further information and details.

Mr. Wiktor stated that he would like to entertain the idea of removing the track in several areas and scrap the ties, donate the land to rails to trails and use the money to fund various Communities in the County.

Mr. Wiktor mentioned to the Board that if it was decided to scrap a portion of the rail road that Mr. Dingman of NY & LE Railroad would still be able to run an excursion train from Gowanda to South Dayton if the CCIDA permitted him to do so.

Mr. George Cregg, Jr. suggested that before any scrap is taken from the Rail road line that the NYS DOT should be consulted to coordinate the removal of the tracks. This would take a considerable amount of time to get this completed. It was suggested that Corey Wiktor investigate the possibility of removing a portion of the line. Ms. Schroder had a question in regards to the environmental issues that would be associated with the removal of the rail line.

A Motion was made by Brent Driscoll, seconded by Joseph Higgins, to renew for a five (5) year term the Operating Agreement with New York & Lake Erie Rail Road – Mr. Robert Dingman subject to modifications. A Roll Call vote was taken, Mr. Buffamante, Mr. Driscoll, Mr. Higgins, Mr. Snyder, Mr. Wimer, Mr. Stahley, and Ms. Schroder voted yes. Motion Carried

A Motion was made by Brent Driscoll, seconded by Joseph Higgins to give authority to Corey Wiktor to investigate the removal of the unused portion of the rail line owned by the CCIDA and report back to the CCIDA Board in regards to costs and legal matters associated with such a removal. A Roll Call vote was taken, Mr. Buffamante, Mr. Driscoll, Mr. Higgins, Mr. Snyder, Mr. Wimer, Mr. Stahley, and Ms. Schroder voted yes. Motion Carried

FINANCIAL REPORT:

The IDA had income in **February 2020** a total of \$58,585.00.

-Mr. Wiktor stated that he had hoped that the four (4) projects in document closing stages would have been closed by now. We are in hopes that these projects will be closed within the 1st and 2nd Quarters of 2020.
