Chairman, Thomas Buffamante called the meeting to order at 9:02 a.m.

A roll call of the Board of Directors of the CCIDA was taken Mr. Buffamante, Mr. Higgins attended in person, Mr. Driscoll, Ms. Schroder and Mr. Wimer were present-via zoom conference call. Mr. Snyder and Mr. Stahley was excused.

A Motion was made by Joseph Higgins seconded by Brent Driscoll to accept the Board Meeting Minutes from September 15, 2021 as presented to the Board. All in favor. **Motion Carried**.

New Applications/Projects

. (#1.) Pivot Solar NY 3, LLC:

The CCIDA received an application from Pivot Solar NY 3, LLC. for the proposed Project of a 2.3MW community solar array build on approximately 14 acres of private land using a single axis tracking system to maximize energy production. This solar project is being proposed in the Town of Yorkshire, NY. A Town Board Letter of Support has been included in your packet.

-Total Project cost/investment of: \$4,677,500 (+-).

The developer Gordon Woodcock has provided the Projects benefits and has stated that the renewable energy produced and transmitted to the electrical distribution system will help New York state achieve its clean energy goals. This solar project will benefit the surrounding Community and also be used for Commercial use. Approximately 16 acres of the 141-acre parcel will be removed from the agricultural projection base for the duration of the project. Upon project completion the system will be decommissioned and returned to its original condition Approximately 29 Construction jobs will be used during the four-month construction term and local vendors will be used whenever possible for supplies and materials during the build.

. (#2.) Allegany Crossings, LLC:

The CCIDA received an application Allegany Crossings for the conversion of an existing property to self-storage and other tenant spaces in the Town of Allegany. This project will take place at the old Kmart building on Route 417 (Exit 24).

-Total Project cost/investment of: \$12,000,000 (+-).

The Developer Mr. Dana Cornell through his Olean-based real estate investment management firm, Cornell Capital Holdings, has an opportunity to push through a project that he believes will directly benefit the Community when completed. Mr. Wiktor said this project is very exciting for the Town of Allegany as this property has been vacant for a period of time. Mr. Wiktor also stated that this project would allow a drastic improvement in the gateway to Allegany from I-86 and could be a catalyst for further development in the area.

Resolution from Prior Application/Project in Process

(#1.) MJ Painting Contractor Corp.:

MJ Painting Contractor Corporation's Public Hearing was held at 9:00 a.m. in the Conference Room at Olean City Hall on October 9, 2021. There was no one in attendance at this Public Hearing. The Resolution being presented to the CCIDA Board is to increase the financial assistance to more than \$100,000 in benefits.

-Total Project cost/investment of \$1,833,500 (+-).

A Motion was made by Joseph Higgins seconded by Michael Wimer, RESOLUTION OF THE COUNTY OF CATTARAUGUS INDUSTRIAL DEVELOPMENT AGENCY (THE "AGENCY") (i) ACKNOWL-EDGING THE PUBLIC HEARING HELD BY THE AGENCY ON OCTOBER 7, 2021; (ii) AUTHOR-IZING FINANCIAL ASSISTANCE TO MJ PAINTING CONTRACTOR CORP., AND/OR INDIVID-UAL(S) OR AFFILIATE(S), SUBSIDIARY(IES), OR ENTITY(IES) FORMED OR TO BE FORMED ON ITS BEHALF (INDIVIDUALLY, AND/OR COLLECTIVELY, THE "COMPANY") IN EXCESS OF \$100,000; AND (iii) RATIFYING, CONFIRMING, AND AUTHORIZING THE NEGOTIATION, EXECUTION AND DELIVERY OF AN AGENT AGREEMENT, LEASE AGREEMENT, LEASE-BACK AGREEMENT, PILOT AGREEMENT AND RELATED DOCUMENTS. A Roll Call vote was taken, Mr. Buffamante, Mr. Driscoll, Ms. Schroder, Mr. Wimer and Mr. Higgins voted yes. Mr. Stahley and, Mr. Snyder were excused. Motion Carried. (Mr. Buffamante stated that his firm does do work for MJ Painting contractor Corp. however, they have no financial interest in the Company or this particular project.)

(#2.) West Valley Solar:

West Valley Solar has asked the CCIDA Board to approve an amendment to their current PILOT to extend the effective date as the project was not completed by the expected date due to project delays.

A Motion was made by Brent Driscoll and seconded by Ginger Schroder, RESOLUTION AUTHORIZING THE EXECUTION BY COUNTY OF CATTARAUGUS INDUSTRIAL DEVELOPMENT AGENCY OF A CERTAIN FIRST AMENDMENT TO LEASE AGREEMENT, FIRST AMENDMENT TO LEASEBACK AGREEMENT, AND FIRST AMENDMENT TO PILOT AGREEMENT FOR THE WEST VALLEY SOLAR LLC PROJECT. A Roll Call vote was taken, Mr. Buffamante, Mr. Driscoll, Ms. Schroder, Mr. Wimer and Mr. Higgins voted yes. Mr. Stahley and, Mr. Snyder were excused. Motion Carried.

Mr. Wiktor also provided to the CCIDA Board Members an update of expenditures of the money allocated for the Great Lakes Cheese Project by Cattaraugus County.

The Agency is also working on closing documents relating to eleven (11) active projects at this time. These projects are projected to close withing the fourth quarter of 2021; several of these projects are in "final document" stages.
